Objective:

To promote the University's internationalisation; to collaborate with other institutions by establishing strategic networks and alliances, by developing training plans and other institutional/departmental/interuniversity projects.

Data storage time limits and criteria.

Data will be stored for the time necessary in order to fulfil the aims for which it was gathered and in order to determine the potential responsibilities that might arise from said aims and data treatment. This will be subject to the provisions of the legislation concerning archives and documentation. The economic data of the activity to be

treated will be stored under the provisions of the General Tax Law 58/2003 of December 17th.

Source of Legitimacy for treating your data.

In order to perform a legal obligation on the part of the person responsible for their treatment.

In order to perform a mission undertaken in the public interest or in the exercise of public powers conferred upon the person responsible for their treatment.

By express consent, should this be the case.

International data transfer to third-country project participants, while respecting the applicable data protection regulations.

The Rights of Interested Parties

You can exercise the following rights with respect to the protection of your data before Universidad de Sevilla:

The right to apply to access your personal data. Everyone has the right to know whether Universidad de Sevilla, for its part, is treating their own personal data, the objective of such treatment, the source of the said data and whether these data have been, or are going to be, shared with a third party.

The right to request that data be corrected or suppressed. Interested parties have the right to request that incorrect data be corrected or, should it be the case, the right to suppress data when, among other reasons, the data are no longer necessary for the purpose for which they were collected.

The right to request that data treatment be limited. In certain circumstances, interested parties can request that the treatment of their data be limited, in which case Universidad de Sevilla will only store them in order to present, or to defend itself from, potential complaints.

The right to oppose data treatment. In certain circumstances and for reasons related to their own particular situation, interested parties can oppose treatment of their data. In such a case Universidad de Sevilla will cease treating this data, except in cases where

it is legitimately necessary, or in order to present, or to defend itself from, potential complaints.

The right to withdraw the permission granted.

The right to present a complaint before the monitoring authority.

In its capacity as the party responsible for data treatment, Universidad de Sevilla will respond promptly and in no case no later than one month after your communication. If you are not satisfied with the outcome, you can present a complaint before the <u>Consejo</u> <u>de Transparencia y Protección de Datos de Andalucía</u>, or Andalusian Data Protection and Transparency Authority
